

Once the panel assessors satifsy with the amended proposal, the chairman can deliberates the latest result to PC for SBX recommendation. Both before and after result must put inside the PD course file. If student cannot submit the amended proposal within that particular semester, the first result need to be submitted to PC for SBX recommendation. The student result will be graded "IP (In Progess)" for that semester. If the student cannot submit the amended proposal within one month, the student needs to get approval from the EP in order to extend 		
	the submission due date. The extension should not be more than two months.
